# Planning for the Future: Tips from the Fraternal Secretary

We in the Scottish Rite office get a number of requests for information every day, and try our best to fulfill those requests. Because of the relentless progress of Father Time we also get requests for the Scottish Rite 14° Ring Service for a deceased Brother, and it is also our duty to fulfill those requests. Unfortunately, on occasion we are not able to offer the 14° Ring Service, since the Brother is no longer a member in good standing. I would like to touch on this topic, and also how it connects with membership in the Blue Lodge.

When you became a Scottish Rite member you received, as part of your initiation, a 14° ring. You also pledged to obey the rules and regulations of the Valley of Cincinnati, one of which is that you pay your yearly dues. These dues are used to assist in paying our assessments to Supreme Council and in the operating expenses associated with any organization. We in the Valley of Cincinnati do not suspend a member until they are delinquent in their dues for two years—this is much more lenient than in most other Valleys. However, there comes a time when the Scottish Rite must make the painful decision to suspend a member, and that suspended member is no longer eligible for any of the rights or privileges of Scottish Rite membership, including a 14° Ring Service.

In similar manner, your Scottish Rite membership is predicated on membership in your Blue Lodge. If you are suspended from membership in your Lodge the Grand Lodge will notify the Scottish Rite of that fact. We are then obligated to suspend you from membership in the Valley of Cincinnati, regardless of your status in our Valley. For example, a life member of the Valley of Cincinnati will be suspended if we are informed that he is no longer in good standing in his Lodge.

How do you avoid this unfortunate situation? First, be certain that your membership in your Blue Lodge is in good order. Many of the Brethren in Ohio have taken advantage of the Endowed Membership program, which allows you to make a one-time payment to your Lodge to ensure that you will be in good standing until that time when you are called by the Great Architect. Additionally, the Endowed Membership program continues to return money to the Lodge after you are gone. In this manner you are able to guarantee your membership and help to provide for your Lodge in the future. Please contact your Lodge secretary for more information on this program.

The Valley of Cincinnati has a life membership program. This is similar to an annuity and relieves a member of the responsibility of paying dues while also adding to the financial well-being of the Valley. The cost of a life membership is based on your age and the current dues in the Valley. For more information about this program please contact the office.

All of us should have a plan in place so that our families do not have to make decisions at a very difficult time. Please indicate in writing if you wish to have a Masonic funeral service and/or a Scottish Rite 14° Ring Service. By doing so there is no question about your intentions. Additionally, the Scottish Rite, and your Lodge, will not contact your family to see if services are desired—such requests should come to us, and to your Lodge, through the funeral home. In that way we are assured that a service is being done because of the wishes of the family. I would also urge each of you to make plans so that, if you are incapacitated and unable to take care of yourself, your membership in your Lodge and the Scottish Rite will remain intact. Membership in these organizations is not something that should be kept secret from your family—include them, help them to understand what your fraternal memberships mean, and they will then realize how important they are to you.
